**MINOR (UNDER AGE 18) RELEASE AND WAIVER OF LIABILITY
AND WAIVER OF ALL CLAIMS AGAINST SPEED RACEWAY, LLC**

Please read this document. It affects your legal rights against Speed Raceway, LLC if you are injured on the premises of Speed Raceway, LLC. By signing this Waiver, you acknowledge that you have read the agreement and agree to its terms.

1. GO KART DRIVING AND RACING CAN BE DANGEROUS!

Go kart driving and racing is a dangerous activity. While driving or racing a go kart or participating in activities on or around the track, you may sustain bodily injury including, without limitation, the risk of death or serious bodily harm resulting from collision between your go kart and another go kart, a person, object or barrier; your go kart may drive into or wedge under the barrier, go through the safety barrier or the barrier may ride up on the front of the go kart due to additional impacts or acceleration or because of the mechanics of a crash. You may sustain bodily injury as a result of intended or unintended actions of the go kart including skidding, overturning, sudden stops, braking or acceleration or the negligent or deliberate acts of another driver; Bodily injury may occur as the result of one go kart riding up on the front or side of another kart due to additional impacts or acceleration or because of the mechanics of a crash; all of the above is risky and you assume these risks freely and knowingly in exchange for the right to engage in the activities conducted on these premises.

2. SPEED RACEWAY, LLC IS ASKING YOU TO GIVE UP LEGAL RIGHTS IN ORDER TO ENGAGE IN RACING AND RIDING IN GO KARTS ON OUR PREMISES.

Speed Raceway, LLC is asking you to give up certain valuable legal rights. You, your personal representative and your heirs hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Speed Raceway, LLC and its owners, agents, officers and employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of your riding and racing go karts. You specifically understand that you are releasing, discharging and waiving any claim or action that you may have present or in the future for the negligent acts or conduct by the owners, agents, servants or employees of Speed Raceway, LLC or any of the designers, manufacturers or distributors of the go karts used on our premises.

Here are the legal rights that you are giving up when you sign this document:

- a. You give up your right to sue Speed Raceway, LLC in a court of law;
- b. You give up your right to trial by a jury;
- c. You give up the right to claim money from Speed Raceway, LLC if you are injured.
- d. You give up the right to claim money from Speed Raceway, LLC if you are injured by another person;
- e. You give up the right to recover damages or punish or make an example of Speed Raceway, LLC.

3. WHO IS BOUND BY THIS WAIVER AND RELEASE?

You are bound by this document. Anyone who has or can obtain your rights is also bound by this document, such as your family, relatives, guardians, executors or anyone responsible for you or your estate.

As used in this document, Speed Raceway, LLC includes Speed Raceway, LLC, LLC and Speed Raceway, LLC WG, LP d/b/a Speed Raceway, LLC together with the people who work for and are associated with Speed Raceway, LLC, such as its owners, managers, employees, officers, directors, stock holders, agents, volunteers, sponsors, vendors and exhibitors.

The rules of safe conduct for all racers are as follows:

- a. Helmets must be worn at all times on the track;
- b. You must be at the age of 6 or older and at least 48 inches tall to race the junior karts;
- c. You must be at the age of 12 or older and at least 56 inches tall to race the adult karts;
- d. You must attend a safety briefing on safety rules and regulations before beginning a race;
- e. You must obey all flags, signs, orders and instructions from track attendants and officials;
- f. Do not run into the barriers or any other objects on the track;
- g. You must wear closed toe shoes while riding or racing in a go kart.
- h. No bumping of karts allowed at any time;
- i. No smoking at any time in the facility;
- j. Long hair must be pulled back in a ponytail in order to avoid severe personal injury;
- k. Know the limits of your own ability to drive go karts and operate your kart within the limits of your ability
